Our program begins with our teacher candidates looking at research and trends surrounding the technology integration in public schools. Our initial focus is on the ISTE NETS Standards for students. The NETS essentially take an interdisciplinary approach to providing students with a road map for being successful and productive in a global environment. However, ISTE has also provided sets of standards for teachers and administrators. By exposing our pre-service teachers to these three sets of standards, they begin to see how integral the immersion of technology becomes across the learning community. These standards become a focal-point as we introduce various learning software applications, curriculum management tools, and hardware devices to students. We demonstrate the relevance of these tools in the educational environment and always connect these tools back to the ISTE Standards and current educational research. Collecting and analyzing data is introduced first through the use of Google Classroom which is designed around the social constructivist theory of learning. Digital citizenship, web safety, and copyright issues are explored by students during the first few days of class. Students are grouped and assigned different aspects of online safety and learning to research. They share their findings by utilizing a collaborative web 2.0 tool of their choice. Then students share their findings with the class in a round-table discussion. Following this discussion, each student writes 3 assessment items using Google Forms. The instructor then imports all of these questions into a single Google form and students are then given an overview of how assessments are administered in a course management system. In the next phase of this process students access the online test of their own making and practice taking the assessment a few times. They are then introduced to the Google Sheets grading mechanism and

can see how they did as a group on the assessment. Then they are taught how to drill down into what the data reveal about the assessment. Students begin to see instantly where the areas of concern are with the assessment which allows them to actualize the quality of the test item or make inferences about whether or not the outcome was included in the teaching/learning process. Next students are introduced to the value of meta-tagging each test item with its corresponding outcome or standard which streamlines the review of assessments with regard to making data-driven decisions about proposed changes/modification to their teaching process. For example, in reviewing a rich data set they learn to identify which students are struggling with specific outcomes and they learn how they can group those students with groups of students who have mastered those particular outcomes and create peer-teaching activities. Universal design is addressed throughout the entire Media and Technology class. Google Classroom is used in a blended approach with students. Google Drive & Google Classroom serves as the digital foundation for organizing all of the course content as well as aggregating all of the usage metrics to arrive at the intended outcomes for the course. Students find themselves immersed in a learning experience that utilizes instant response polling, forum discussions, blogging, exploration, creativity, research, standard assessments, rubric assessments, content sharing, open-source content, multi-media creation, and web publishing. In addition, teacher candidates use Google Drive to create sample learning activities. Other activities are addressed by using open-source software, web 2.0 applications, open content, and the creative commons. In addition each student learns during the first week of class how to create a digital portfolio and they begin keeping class artifacts in that portfolio throughout the semester. The portfolio becomes a significant portion of their semester grade. The overarching goals of this program are to prepare our pre-service teachers with the skill set necessary to engage a generation of learners who have lived a life immersed in technology, but do not necessarily have the skills to become productive, literate and collaborative in a global economy that will evolve in ways that can only be answered with speculation. We also want our teachers to realize that technology is only a tool that enhances the many intricacies of teaching and learning. Used wisely and effectively technology becomes an enabler but it does not replace the essence of what teaching and learning is all about. Therefore we prepare our students with a framework of proven instructional methodologies as well as emerging technical competencies to position themselves as effective teachers for the 21st Century.

All program lesson plans prepared by candidates include adaptation/accommodation information. All formal clinical experiences require the candidate to gather contextual information related to diversity and special needs within his/her sphere of observation. All candidates take a class, Education of the Exceptional Child, in which various exceptionalities are carefully considered with emphasis on methods and techniques of identification, instruction, and finding available resource assistance. Specifically included in the course, but not limited to, are learning disabilities, autism spectrum disorder, emotional/behavior disorder, deaf, blind, other health impaired, severe-profound/multi-handicapped, gifted/talented, and mental illness. Attention to IEPs and the resulting lesson plan modifications are introduced in Orientation to Teaching and included in most methods classes. Classes such as Human Development and Learning as well as Educational Psychology include attention to exceptionalities, multiple intelligences, and learning styles/modalities. ELL is an integral part of our Diversity Action Plan. This can be seen by the following excerpt from the diversity proficiencies: Teacher Candidates are expected within the Knowledge Category to: Be aware of the needs of and effective strategies for working with an English Language Learner (ELL), such as: a) Building blocks of language b) Stages of second language acquisition c) Context matters; students are competent in home language d) Different dialects of English e) How to use multiple assessments to determine what students know f) Important connections between language & culture. And within the Skills category to: a) Demonstrate a variety of strategies/techniques proven to be effective with ELL b) Demonstrate a high novice proficiency in a foreign language. These elements are addressed in many of the professional education courses and many of the methods courses. One example would be a required course of all teacher candidates, Educational Psychology. Discussion in this course includes teaching implications of additive and subtractive bilingualism, and dialects; how to implement culturally relevant teaching; components of effective specially designed academic instruction in English (SDAI); SIOP Model of Sheltered Instruction, and general considerations for working with ELL.

We have a program that prepares educators for students who are deaf/hard of hearing. The entire program focuses on language development and learning related to this special group of students who are limited English proficient. In addition to the language and culture of people who are deaf/hard of hearing. The program assures that the future educator is well-grounded in content knowledge. One course includes a heavy focus on individualized education program preparation and collaboration. Legal issues are infused throughout the program.

The co-teaching approach to USAO's Professional Trimester began with 22 teacher candidates in fall 2013 and 18 in spring 2014and 32 in 2014-15. As revealed by mentor and principal evaluations along with a teacher candidate focus group, the 2013-14 teacher candidates showed enhanced development in confidence and collaborative ability. Under the traditional student teacher system candidates had approached daily preparation solo; coteaching, however, appears to result in a stronger understanding of standards-based curriculum through closer collaboration with mentor teachers. Candidates felt they were getting more classroom experience with this new approach. Their co-teaching initial training and orientation session allowed them to view the previous structure of student teaching, giving them the ability to compare student teaching to co-teaching. Positive feedback has come from school superintendents, principals, and teachers since implementation began. By July 2014 approximately 200 mentor teachers had been trained. From conversations with mentor teachers, co-trained teachers, principals, superintendents, and teacher candidates, the Coordinator of Clinical Experiences has detected that mentor teachers implement co-teaching strategies even without a student teacher. There is evidence in evaluation data and responses to the clinical coordinator that trained mentor teachers are employing co-teaching strategies with Clinical 1 and 2 candidates. Beginning January 2014 the strategies were embedded into Clinical 1 and 2 classes, Language Arts, and Classroom Management/Evaluation Theory. The Early Childhood Cognitive Skills class as well as Curriculum and Program Planning class began including co-teaching strategies in class and applying the strategies in the Child Development Center in fall 2013. Since July 2014, approximately 100 more teachers have been trained and 32 more teacher candidate have used or are using the co-teaching approach to student teaching. Certification programs in Early Childhood, Science, Elementary Education, English, and Social Studies were recently nationally recognized by their respective specialty associations. The Art program was state recognized. Music and Deaf Education are nationally recognized under a different cycle. The programs in math, and physical education are preparing reports in response to conditions.
