AMENDED AND RESTATED CERTIFICATE OF INCORPORATION

The undersigned corporation, hereby amends and restates its certificate of incorporation, as follows:

Article I

The address of its registered office in the State of Oklahoma is: 1727 W. Alabama, in the City of Chickasha, Grady County, Oklahoma 73018

Article II

The name of the registered agent is JP Audas, at the same address.

Article III

The duration of the corporation is perpetual.

Article IV

- (a) The corporation is formed as a not-for-profit public charity for the purpose of supporting the University of Science and Arts of Oklahoma (USAO), and other qualified organizations as deemed appropriate by the Board of Trustees.
- (b) The corporation administers and operates for educational purposes.
- (c) The corporation receives and manages gifts, donations, and private resources supporting the mission and priorities of USAO, in accordance with donor intent and those further educational purposes and goals deemed appropriate by its Board of Trustees. Such distributions of corporate assets are made and authorized solely by the corporation's Board of Trustees. No other entity, person or successor in interest to USAO shall have authority over the assets of the corporation, absence the express assent and approval of the corporation's Board of Trustees.

Article V

The corporation is authorized to receive gifts to USAO in support of the mission of the university. Upon receipt, the Board of Trustees is responsible for the control and management of such assets, to be utilized in a manner consistent with donor intent, for the benefit of USAO, and such other educational entities and goals as determined by the Board of Trustees. Distributions of the assets held and managed by the corporation shall be made at such times, and in such manner and amounts, as the corporation's Board of Trustees in

NOV 13 2024 OKLAHOMA SECRETARY OF STATE its sole discretion deems to be proper. The corporation, in accordance with its Bylaws, shall hold all powers reasonably necessary and incidental to the accomplishment of the purpose of the corporation.

Article VI

The Bylaws of the corporation may be altered, amended or repealed in whole or in part by the Board of Trustees at any annual, quarterly or special meeting, provided that written notice of such meeting shall be given prior thereto, and such notice contains the essence of the contemplated alteration(s), amendment(s) or repeal(s).

Article VII

In the event of the closure, consolidation, merger or any similar event involving a change in status of USAO, the corporation's Board of Trustees shall, in its sole discretion, determine the future use, transfer, and distribution of any and all assets then held by the corporation. The closure, consolidation or merger, or any other event constituting a material change in USAO as a public university, shall not constitute grounds for a successor in interest to this corporation. All decision-making in conjunction with such an event, insofar as the status of the assets of the corporation, shall be the sole responsibility of the corporation's Board of Trustees.

Article VIII

The corporation's Board of Trustees and Executive Committee have approved of and authorized the articles of the Amended and Restated Certificate of Incorporation. Upon the direction of the Board of Trustees, the undersigned officers hereby affix their signatures.
