 - c. Discussion and possible action: An Even Playing Field Resolution Senators Alldredge and McGarrah
 - i. Questions & Discussion:
 - 1. Q Cracknell: Do you guys know why athletes get priority?
 - A Authors: Yes, we spoke with VP McConnell, and he gave us a rundown. We understand why athletics use this, but he also stated that this was entirely possible for this to be extended to other departments.
 - 3. Followup: What's the student feedback?
 - 4. A Authors: I think that all students would benefit from guaranteed housing, I haven't surveyed students, but I have spoken with many Deans. This is also optional for departments to partake in. For the music department specifically, a lot of us already live together, so having the ability to foster a sense of community and solidify spots to continue.
 - 5. Followup: He's heard that VP Ross felt blindsighted from this and would've liked to be spoken to about this.

- A Authors: We did reach out to him and set up a meeting with him, but he did not show up. The legislation present is the revised edition from my meetings.
- 7. Q Jones: Do you foresee any negative connotations with people who do not do this?
- 8. A Authors: There's only to benefit from this, especially in the context of the revised legislation compared to the original one, which took away housing blocks from all departments. Furthermore, as a transfer student from UCO, I have seen personal success in the implementation of this, where not only did students compete to get into this housing, but
- 9. Q Guillen: I have a concern with the larger departments versus the smaller departments. How do we avoid certain departments being chosen over others?
- A Authors: I could see the implementation of this placing limits on the number of purchased housing places, but I would defer this to administration.
- 11. Followup: How would this affect scholarships?
- 12. A Authors: There wouldn't be any additional money from scholarships, the departments purchase the housing blocks themselves.
- 13. Q Brockman: Did you reach out to housing on physical limitations?
- 14. A Authors: I did reach out to meet, but I don't think a time was ever figured out.

- 15. Followup: You've reached out to meet on the original bill, but not the revised one?
- 16. A Authors: Yes.
- 17. Q Chatman: How is this decided?
- 18. A Authors: This is as the department sees fit.
- 19. Q Cracknell: Could you tell us Shepard's opinion on this?
- 20. A Authors: Yes, Shepard was originally opposed to the idea, but we found a compromise and he now agrees with it. He has stated that this is definitely possible for departments. The biggest thing to be accomplished from this is letting other departments know that this is a possibility, not a requirement.
- 21. Followup: I'm just a bit confused, is this not disadvantageous to other departments?
- 22. A Authors: No, it is not. I was validating Senator Guillen's concerns for smaller departments, but as I see it, it would not be disadvantageous to other departments.
- 23. Q Guillen: Is it a reasonable concern that some departments would struggle to purchase housing blocks? So, would they be disadvantaged in this way?
- 24. A Authors: I would argue that all departments besides athletics are disadvantaged for this. I would say that moving towards a point where more departments use this would be more fair than others.

- 25. Comment Jones: Something that I was thinking about, we don't have to vote on this, and then it's over as soon as it's over. There's still the opportunity to continue to converse about this.
- 26. Q Cracknell: How would departments raise money for this?
- 27. A Authors: Charging for performances, different departments can fund this in different ways. I won't claim to know everything about all departments, so I wouldn't want to figure out what's best for them as a god of USAO of sorts. From my time at UCO, there are plenty of ways for departments to fundraise. The problem we are striving to address is not funding. The problem is "Is this equitable?"
