 - i. Questions & Discussion AS A BLOCK:
 - 1. Q Guillen: With the ones that were passed previously, what was amended to ensure these would get passed?
 - 2. A M Alldredge: From my understanding, they were not able to be seen by the president. I did change the annexes one, as well as the mental health matters
 - 3. Q Followup: Did you pass these through Rachel?
 - A M Alldredge: Yes, except blocked braille which was through Dr. Hwang
 - 5. Q Cracknell: Did Rachel say it was possible? How much would it cost?
 - 6. A M Alldredge: Yes, its possible, but I dont know how much it costs
 - 7. Q Cracknell: New counseler hired?
 - 8. A M Alldredge: Yes, but they're phasing out the old one, so we're at net zero.
 - 9. On information Brockman: We will be hiring a full-time counselor.
 - 10. A M Alldredge: That is amazing, but I fear that one counselor is not enough for all of our students.
 - 11. Q Followup: With the visibility strips, do you have an estimate on costs and when they'll be implemented?

- 12. A M Alldredge: No, I don't know how much it'll costs, I leave funds up to the experts who are best able to implement it to our budge tneeds.
- 13. Q Guillen: could you see any gaps where TAO would fit it?
- 14. A M Alldredge: TAO is videos, so it's not online counseling. Rachel also felt concern feeling that videos aren't enough for more moderate mental health issues Q Roberts: Did you change the accessibility terminology language?
- 15. A M Alldrege: No
- 16. Q Roberts: we did bring that one to the president, and its being worked on, but Dawn has followd up on it to get iti odne.

- 28. A M Alldredge: I do see your point, I don't want to say Dilly didn't see the importance of it. Committees are able to produce reports based off of resolutions, so the resolution is the recommendation itself, but the committee can conduct a detailed report from that. The more specific I make it, I don't have the qualifications of Rachel Dreschler or other experts. They're vague because I know the issues exist, I just want to bring light to them.
